Thursday 23rd November

1. Welcome (Bernard Lovewell)

Our Chairman opened the Meeting by thanking our members and their guests for attending.

Apologies for Absence Alan Thomond, Ted Foster, David Baxter (I'm afraid that I have misplaced my notes but please contact me if you did offer your apologies and I will add them to the final version of the Minutes)

3. Minutes of the 2022 AGM

The printed copies of the Minutes were read and accepted by those present.

Matters Arising

There were no matters arising.

Chairman's Report

Bernard confirmed that we would continue to arrange functions at venues around the country for our members and their guests in order to cater for our ageing membership to enable that as many members as possible would be able to attend and meet their former colleagues. He thanked our Committee Members for their continued support and their efforts, which ensured that the Club could and would continue to function. In conclusion, Bernard paid respects to Susan Sutcliffe for her role as our Welfare Officer, when she stepped in to ensure that the Club would continue to function for the benefit of its members and, finally, mentioning the role that Arthur Rowe had played in ensuring that, as a Member of the Union Jack Club, the cost of hiring the function rooms was reasonable for a central London location.

Treasurer's Report

In the latest edition of Barclays' 'Archives Reviewed', the following article appeared, headed: 'The changing face of retail banking' As Barclays continues to adapt to changing customer needs, we are striving to keep abreast of the latest developments. There is no doubt that banking is currently in the process of monumental change, and it is essential that we capture that. We keep careful records of branch closures, as we know that colleagues in Customer Relations will need this



Although we continue to have a substantial surplus, 2024 will be the 55th Anniversary of our takeover by Barclays and I believe that we should offer all of our members a benefit, which should be discussed at this AGM.

New members continue to join our Club, but with the youngest being at least 70 years of age, 'Lifetime Membership' for £5 must be considered as becoming dated and I would suggest that we agree to cancel this cost to new members joining our Club from 1st January 2024, with which I trust you will

Although the completion of the renovations to our former Head Office building has been delayed, and will not be completed until 2025, I believe that we should offer our members who attend our functions a benefit at our 2024 'Remembrance Lunches' in December 2024.

With our 'Guests' obtaining the same benefit as our members but, for whom we cannot claim any funding, I also believe that the structure should be revised and would like to propose that cost for attending should be:

> Member £10.00 Guest £30.00

This would mean that our members who ask a guest to accompany them will be paying precisely the same as they do at present whilst our members, who attend in their own right, will benefit from a reduced cost. The removal of the Membership Fee, when coupled with a two tier pricing structure, may also result in the addition of a few 'new' members who, though former Martins staff, have attended as a guest.

This year, our membership numbers have increased yet again from areas outside London and, as Robert did last year, I believe that this geographical spread must continue to be recognised, with the areas outside London having been the source of the surplus generated this year.

I must also thank our Committee members for continuing not to claim any expenses when attending our functions and collecting items donated by members.

Secretary's Report

The Secretary had nothing to report

Welfare Officer's Report

Before her untimely death, Sue Sutcliffe had nothing to report. Our Secretary, David Baldwin, said that he has been dealing with a complex problem for one of our members and asked if our members would support him in writing to the Pension Fund Trustees in support of a member saying that for obvious reasons of confidentiality he could not disclose the problem. The members present gave their unanimous support.

9. **Election of Officers**

As the current Officers were willing to stand for reelection and Ken Quirk had offered to become our Welfare Officer, as there were no other nominations the current Officers were re-elected en-masse.

Election of Auditor

It was unanimously agreed that our Treasurer should obtain a third party, to audit the Club's Accounts.

Any Other Business: PROPOSALS 11.

Cancellation of Membership Fee: For former a. colleagues becoming members of the Club, it was proposed that the £5 Membership Fee should not be charged with effect from 1st January 2024.

Passed unanimously.

With a sudden surge in new member applications, following the 2023 end-of-year lunches, the membership Fee was waived for all of our new members.

Can my ultra vires actions be ratified at the 2024 AGM?

Future 'Function Fees': As a 'Members' Club', it was felt that Members should benefit from any savings that could be obtained.

With effect from 1st January 2024, Function Fees will be:

Members £10; Guests £30.

Effectively, this would mean that there would be no change for Members who invite a Guest, as their guest would not be expected to pay, and would continue to pay £40 whilst Members would only pay £10 and thereby obtain their deserved benefit from being a Member.

Passed by the majority of members with only one dissention.

There being no other business, the Meeting was closed at 13.10

In 1969: With the upcoming merger, this became something of a nightmare. Replacement Barclays' stationery seemed to arrive by the lorry load, all to be stored somewhere as the 12th December approached.

Birkenhead. I stayed there in 1967 whilst on a cashiers' course and I remember catching the ferry each morning and evening. In November 1968 I stayed at a hotel whose name I cannot remember (Editor: The infamous Alexandra Court?) but

John "Eric" Davies was born on 26th June 1928, and having been raised in Oldbury, Eric became an air traffic controller at RAF Biggin Hill during the 2nd World War, with his family learning that he regularly let off a flare gun to

In 1984, Eric was appointed Colmore Row, Birmingham - Branch Director (one of only six in the country), before retiring in 1988 (aged 60).


THE 68 LOMBARD STREET CLOCK








arena. I thought it

I thought I'd pass on a few memories from my time in Martins.

I joined the bank in 1966 at Hamilton Square in Birkenhead straight from school. I can still remember all the names of the staff which must say something for the camaraderie at the branch.

I do remember vividly the grilling I got the first day from the girls in the machine room was far more intensive than the interviews I had to join the bank!

The branch was situated not far from the police station and on occasions an officer would come in and ask if he could "borrow" some of the younger male staff to partake in an identity parade. This was always a popular diversion from work for an hour or so, even though we had to work doubly fast to catch up when we returned. Somehow I don't think the police could get away with it today, but 7 or 8 young men from the local banks, all dressed smartly in suits and ties were lined up and then a scruffy unshaven youth in dirty 'T' shirt and jeans would be brought in and allowed to place himself in the line-up. The offender stood out like a sore thumb, but it was amazing how often a witness would pick a bank clerk! For our efforts we were all paid two shillings and six pence, always a bonus to our meagre pay!

Another fond memory was being regularly sent on relief to a small sub branch in Meols on the Wirral. As I lived in the village with my parents it saved the train fare and I could go home for lunch! The look on the faces of neighbours when they walked into the branch was priceless! One particular customer I remember was a small elderly lady who always arrived on the same day each week at exactly the same time. What made her so different was that no matter what time of year it was she would be dressed in a big hat, gloves and a very long mink coat that was extremely threadbare. To make the arrival even more special was that she arrived in a chauffeur driven two door Morris minor convertible. Her chauffeur always wearing a peak cap, gauntlets and buttoned up suit would rush round to open the passenger door to help extract her from the rear seat. She would never pass any pleasantries and made it quite clear that she didn't want to talk.

It was the highlight of the day!

Well that's just a couple of many happy memories which I hope you can use.
