Bernard McGuinness

Juan Mc Guinness advised me of his father's death, writing: My father Bernard Francis McGuinness received your newsletter as an ex-employee of Martins Bank, sadly he passed away on 17th May 2025. He was 85 and I was by his side when he passed away peacefully.

Born in 1939 in Liverpool he joined Martins Bank from school at 16 and, other than his national service, worked for Martins Bank (and then Barclays) until his retirement in 1999.

He worked in various branches in the Liverpool area before moving to Ramsey branch of Barclays on the Isle of Man in October 1971 where he stayed for the remainder of his career.

I know he had a lot of fond memories of his time with Martins Bank and enjoyed reading the newsletters and even managed to attend a Pensioners dinner or two travelling over from the Isle of Man.

Bernard actually started his Martins career in Manchester District, before transferring to Liverpool, where he worked at our Bootle branch followed by Chief Accountant's Department from which he commenced his National Service at R A O C Blackdown in Hampshire. On completing his National Service, Bernard was allocated to 99, Stanley Road, Bootle branch and finally, before our takeover, Clubmoor.

John E Davies joined Martins' in our Midland District in 1953 where he spent his entire Martins career working in Walsall, Birmingham City Office, Midland District Office, Birmingham Five Ways, Dudley and Birmingham



Digbeth It is the sort of branch which gives forth a



friendly and homely feeling and one in which the staff can take a pride. A sign of the passing of time is to be found in the appointment of a Midland District man to be the first manager. Mr. K. R. Chance, who opened the branch at Shirley, was the first; Mr. J. E. Davies is the second. The District is now old enough to be producing some of its own management

personnel, a very good and healthy sign. Mr. Davies was educated at Oldbury County High School, and entered the Bank in 1953. He has served at Wednesbury, Walsall, Birmingham City Office, Birmingham Five Ways and at Midland District Office, where he had an all-round training both on Outdoor Inspection and on the loan side. He was a founder member of Oldbury Round Table and is now its Chairman. He is also a member of the British Chamber Junior of Commerce Birmingham. Second-in-command is Mr. A. Warren who was until recently Accountant at Birmingham City Office, a post which he unfortunately had to relinguish owing to temporary ill-health. We first had the pleasure of meeting him on the occasion of our visit to Kidderminster in 1957 and the new branch is fortunate in having such a sound and experienced man to help it along.

The contract of sale for scrap precluded selling on and considerable negotiations were required with BR before this was rescinded and 43924 became the first of around 200 locomotives to escape from Barry and become the backbone of the Heritage Railway industry we know today.

In the back of the van was £92,139. It had just made its last call at the bank's Longfield branch where it picked-up a suitcase containing £8.261.

Then the unexpected happened. On a lonely stretch of road between Lonfield and Green Street Green, eight bandits in muslin masks, carrying iron bars, pick-axe handles and Indian clubs, swooped on the van.

"The bank men were terrified. One of the bandits was able to get into the van in the extremely audacious way of climbing through a smashed window," said Mr John Gower, prosecuting, at Kent Assizes, at Maidstone.

He was the only bandit to get inside the back of the van but he was able to hand out six suitcases containing £87,300.

Said Mr Gower: "The bank officials were not there as guards but for collecting and delivering the money. Because they were not there as guards not one of them was provided with any means of defence or offence except his own hands. It is not for me to express views on the rights or wrongs of that."

Someone shouted to the driver 'Keep going George; it's a raid'. I jumped to my feet and looked out of the back window.

"I saw some men-I think there were about four or five of them- running towards us. They all had masks covering their faces."

He said the men surrounded the van, banging on the sides and shouting threats like 'Open up, or we'll kill you.' We all crouched down on the floor of the van. A masked man got in through the smashed window and said 'Keep quiet."

Mr. Hutchings then described how this bandit picked up the suitcases and sorted them out. "He threw the empty cases to the front of the van, and threw the full ones- the cases with the money in them- out of the window.

"Then he climbed out of the window the same way he had entered"


JONATHAN SNOWDEN

MINUTES of the 2024 ANNUAL GENERAL MEETING

1.
